Lifequards will be working at small condominium pools alongside Big Splash supervisory team. Most of the pools are only 5 feet deep.

Lifeguards must constantly monitor guests in pools and surrounding area and ensure that
guests follow the pool rules. Lifeguards will be next to or in chlorinated water and will be in
direct sunlight for long periods of time. Participants will be standing, sitting, and walking for
long periods of time.

Lifequards must ensure a safe and healthy environment for the swimmers. Lifequards must be able to recognize and react properly in emergency situations.

Upon arrival participants will also take a pre-certification test to determine their swimming skill level. If the instructor feels they will not be able to complete and pass the assessment, participants will not continue with the certification process and therefore not be charged the fee. Participants will be asked to work as a pool attendant which does not require the certification. However, this is a limited position and may limit the amount of work hours received.

Pool attendant job duties include logging guest in and out, testing pool chemicals, cleaning the pool and pool deck. A Pool Attendants main duty is to oversee the pool area and make sure all rules and regulations are being followed

Participants will also be asked to clean and service pools to gain additional hours. Most of the pools are at communities and condominiums. In the beginning and end of the season, participants must be willing to assist with the opening and closing process of the pools. This includes covering and uncovering the pool, cleaning them and bringing out pool equipment/furniture. Additional duties will including cleaning and vacuuming pools, testing pool chemicals, recording readings, checking pool passes, and watching residents in pool.

Lifeguards will do pool attendant roles as well basic lifeguard duties.

Participant must pass a company recognized certification, as well as a written and swimming test to become a lifeguard. The cost of the test is approximately \$350.00. Participants will be responsible for all certification fees. The host prefers participants to get the certification in advance; it is cheaper and faster for participants to complete prior to arrival.

**If participants choose to get Lifeguard Certified in their home country they must check with their employer that it is a certification they will accept. The most widely accepted certification is Red Cross.

If Greenheart Exchange rejects the SAJO, the participant has one (1) business day to resubmit a new or a revised SAJO, based on the directions received from Greenheart Exchange. If the participant no longer has housing, the participant must look for permanent housing immediately, and within two weeks must secure permanent housing that complies with Greenheart Exchange's Housing Guidelines. The new housing address must be submitted to Greenheart Exchange within 24 hours of any change of address.
